The following activities were carried out during the year 2021- 2022.

2. FACILITATING QUALITY EDUCATION FOR CHILDREN

2.1 INTERVENTION IN ANGANWADIS

ARCOD – ILP Project is working with 75 Anganwadis covering 2500 children. The Project team collected the basic data of 1500 Children.

Growth Monitoring: Height and Weight monitored for 1492 Children. The Project Coordinators facilitated the distribution of dry ration foods to the children door step during the lock down period.

Health Checkup: Health Checkup was done for all AN and PN Mothers with the assistance of VHN and ASHA workers. The health checkup was also done for all Anganwadi children and Adolescents. The project team monitored the Adolescents taking iron tablets.



Preschool education awareness program was conducted by the Project Coordinators in all the 75 villages in the month of July 2021.

The Project Coordinators took session on AN & PN Care as resource persons in three Anganwadi workers training programs held at Thally block conducted by ICDS. The team also explained about the importance of taking nutrition foods and preschool education of children.

2.2 SCHOOL MANAGEMENT COMMITTEES:

The SMCs did not conduct the monthly meetings due to lock down and closure of schools. However, the project team managed to organize the meetings of 12 SMCs. During the meetings the staff team emphasized the members of SMCs to motivate the children to watch “Kalvi Channel” and to read books.

2.3 CORONA SPECIAL EVENTS

Due to the Corona Pandemic and closure of all Schools not only school going students but also the general public were severely affected both healthily and economically. Hence the ARCOD – ILP team interacted with general public and prepared case studies on the impact of Corona pandemic. 4 such case studies were submitted to ILP.

Interviews with the stakeholders (Head Masters, Teachers, Parents and Vidhya Saathis) were held to find the impact of COVID with respect to education of the children. 8 such interview visuals were recorded and submitted to ILP.

The Project team gave awareness to the children about safety measures and facilitated the general public to get vaccinated with the help of health department.



ARCOD – ILP Project sponsored Covid – 19 Medical Kits (Comprising Face Masks, Pulse Ox meter, Face Shield, Sanitizer and Gloves etc.) worth of about Rs. 75,000/- to 5 Primary Health Centers in Rayakottai, Nagamangalam and

Unichetty in Kelamangalam block and Baladhottaanapalli & Kakkadasam in Thally Block.

2.4 PREPARATION OF PPTS

During the reporting period, ARCOD – ILP Project team prepared 44 Power Point Presentations for Social Science subject of Tamil Medium from 6th to 10th standards. These PPTs were uploaded in the ILP Website.

2.5 VILLAGE LEARNING CENTERS

Students' academic learning was severely affected as the schools were closed for long days due to corona pandemic. Hence the ILP Project decided to establish Village Learning Centers (VLCs) like evening tuition to improve the academic learning of the children studying in primary schools. For this purpose, we selected 30 villages in Thally, Kelamangalam and Shoolagiri blocks after collecting basic data by the project team to implement the scheme.



The VLCs were inaugurated in the month of August 2021 with the support of the parents, teachers and local body members. Basic needs like black board and stationaries were provided

by the Project. The Project Coordinators visited the VLCs weekly twice to monitor the functions of VLCs and monitor the attendance of the children. Totally 850 primary school students benefited through these VLCs. We issued English workbook to 850 children in these VLCs. 5 themes are completed up to March 2022. Assessments were done for 850 students for Tamil, English and Maths using the PRATHAM ASER tool.

2.6 SUPPORT TO “ILLAM THEDI KALVI”

The government of Tamil Nadu is implementing the scheme “Illam Thedi Kalvi” to improve the learning of the children. The project decided to motivate and support the children of these scheme. The project team organized competitions for the children and distributed prizes to the students of 80 centers.

2.7 TRAINING TO VIDYA SAATHIS

We selected 30 Vidya Saathis (Local Volunteers) to look after the VLCs. These volunteers were identified from local villages. A training program was conducted by the project team for Vidya Saathis on 27th July 2021 and 12th January 2022. Fundamental teaching methods and technics of Language and numeric for the subjects of Tamil, English and Mathematics were covered during the training. The roles and responsibilities of the Vidya Saathis and functioning of the Village Learning Centers were also explained in detail.



2.8 CAREER COUNSELING SESSIONS

Career Guidance and Counseling Sessions were conducted in 84 villages during the reporting period. 5660 students attended these sessions. We guided the students in Basic courses in higher studies, conducted Holland coding test and displayed the Career Guidance and Counselling Chart and explained about it in detail. The following table shows the results of Holland Code Test.

2.9 LIFE SKILL TRAINING

Since the schools were closed, the life skill training sessions were organized in the villages. Totally 2349 students benefited in these programs in 81 villages.

2.10 MOBILE LIBRARY

Like the last year, the project team brought books to the villages this year too. The students were called to a common place in the villages, the staff team guided them to read the books. This helped the ILP team to assess the Reading Level of the students. Through this mobile library our team covered totally 1840 students.



2.11 RE - ENROLLMENT OF DROPPED OUT STUDENTS

One of our staff found that a group of students were dropped out of school in Nandhimangalam village in Thally Block. He went to the village and met the parents with the help of school teachers and enrolled them in the school. Another staff motivated and given counselling to 12 students who finished SSLC and did not join 11th standard. He facilitated the students to get admission in 11th standard. Totally 34 students were enrolled in the schools in Thally block through our staff's effort.

2.12 LEARNING LEVEL ASSESSMENTS



Learning Level Assessments were conducted in 30 VLC based feeding villages. The assessments were carried out during the month of September 2021 for the students studying from 3rd to 8th standards for all 5 subjects. 3487 students participated in the pre assessment and 3957 students in post assessment. 3095 students participated in both the assessments.

3. KRISHNAGIRI CHILDLINE

Childline Project is supported by the Ministry of Women and Child Development, Govt. of India through Childline India Foundation (CIF), Mumbai.

Krishnagiri Childline is operational since 2012. ARCOD implements Childline in the capacity as Collaborative Organization. The CHILDLINE team has been involved in creating Awareness on Childline Services in the district since its inception. The calls through the Helpline No. 1098 are received through the Central Call Center at Chennai. Then CCC team passes on the information to the district team. The District Childline team intervenes accordingly. The following activities were carried out during the year 2021 – 22.

3.1 CHILD PROTECTION COMMITTEE MEETINGS

Childline is a member of district child protection committee. The meeting of this committee was held on 9th october 2020 at krishnagiri. The staff team of childline are members of block level child protection committees. 4 block level meeting of these committees held during the year.

3.2 CHILDLINE SE - DOSTI PROGRAM

Se Dosti is a weeklong event organized at the national level during the children's week to create awareness on Childline and its services. The following events were organized as a part of Se Dosti Program:

3.2.1 SURAKSHA BANDHAN & SIGNATURE CAMPAIGN:

The campaign was organized at the Collector Office Campus, Krishnagiri on 15th November 2021. 26 children participated and knot the Suraksha Bandan to the District Collector, The Superintendent of Police and other district officials. A signature campaign was also organized where all the participants declared them as Childline Friend and signed. 44 adults also participated in the event.



3.2.2 PRESS MEET: The media persons were oriented on the details of interventions of Childline for the year during the press meet held on the 15th November 2020 at Krishnagiri. The print and television media persons took part in the meet.

3.2.3 DRAWING COMPETITION: The drawing competition was organized on 22nd November 2021 as a part of the Se Dosti Program in Panchayath Union Primary School, Billikkal Village, Urigam Panchayath, Thally Block. 23 children actively participated in the competition and drawn pictures.

3.2.4 PUBLIC AWARENESS: The events were organized across the district during the week to mark the Children's week and create awareness for the public on Childline, child rights etc. A rally of the children was organized in association with the Districts Legal Services Authority, Krishnagiri on 14th November 2021. About 150 children took part in the rally and tied Raksha Bandhan to the officials of the various allied departments.

3.3 OPEN HOUSE

Open House program is an awareness program conducted once in a month. This year the villages to conduct the program were chosen based on the vulnerability of child related issues during preparation of City Action Plan. The open house programs were organized in such vulnerable villages in a common place. Entire Childline team was involved in organizing these programs. Various cultural events, sport activities and quiz programs were conducted for the children during these awareness programs. These awareness programs were designed to highlight the issues pertaining to children like Child Marriages, Children dropping out of school, Children involved in begging and online classes. The Childline team has also provided inputs for the children and parents to cope up with the situation of COVID 19 pandemic and its consequences.



3.4 STAKEHOLDERS MEETING

Meeting of the stakeholders was organized at Krishnagiri on 03/03/2022. The purpose of this meeting was to discuss the challenges and resources with regards to the children with the organizations working for children in the District. District Child Protection Officer, CWC members, Anti Trafficking Police Unit, NGOs and representatives from other organizations working for children participated in the meeting.

3.5 AWARENESS PROGRAMS

Awareness is a part of routine work in Childline to make aware the general public of the functions of Childline apart from addressing the interventions. Following awareness campaigns / programs were organized during the year.

During the program information on Childline and its services was disseminated through cultural programs, pasting stickers, group discussion, and issue of notices etc.

3.6 INTERVENTION

CHILIDLINE received 1258 calls during the year and intervened in 650 cases for the following categories. The other calls were not needed intervention.

4. FACILITATING FARMER PRODUCER COMPANIES

ARCOD has been facilitating three Farmers Producer Companies (FPCs), one in Anchetty and two in Rayakottai with the support of NABARD to make agriculture as a viable and income generating activity by reducing input costs and increasing the market prices for the farm produces through direct linkages.

Vetri FPC already involved in many business activities. Following the success of their business activities Vetri FPC got a work order to manage Hosur and Denkanikottai Primary Processing Centers. A Seed Processing Unit worth Rs. 60 Lakhs sanctioned by the central government. The Company purchased lands at Anchetty and Sesurajapuram to construct Vegetables collection center, Rural Mart and Office. At present Vetri FPC is functioning independently.

Based on the inputs and motivation given to the board of directors, Yermunai and Pasumai Boomi FPCs also started the business activities.



4.1 YERMUNAI FPC AND PASUMAI BOOMI FPC

The formation of the two companies completed and both the Companies were registered under companies Act 1956 / 2013 in April 2020.

During the Corona pandemic both companies struggled to mobilize the farmers and collect the share amount from the farmers. The Board of Directors and CEOs of the two companies put their efforts and mobilized shareholders for the FPC and reached the target of 1000 shareholders in March 2022.

“YERMUNAI Farmers Producer Company Limited” collected share amount of Rs. 5,05,000/- and “PASUMAI BOOMI Farmers Producer Company Limited” collected Rs. 5,16,000/-.



4.2 TRAININGS & EXPOSURES

ARCOD organized and conducted 2 Capacity building programs 2 days each and Business model preparation for FPOs to the Board of Directors and CEOs of the both FPCs during the financial year at ARCOD - Namma Veedu, Rayakottai.

The Project team organized a two days exposure trip for the Board of Director and Lead farmers to Leaf, Mettupalayam to visit their primary processing center for vegetables and fruits. The FPC team learned

about the processing like cleaning, sorting, grading and packing of the vegetables and maintaining the cold storage. If better price for the vegetables is given by the Leaf, the BoDs



and the farmers who took part in the Exposure trip like to do business with Leaf. These trainings have given insights of the FPOs and the team got many ideas on developing the FPOs.

FPC team organized a two days training program on Dairy based Livelihood development in June 2021 for the farmers of the two FPOs with the help of ESAF, Thrissur. A Doctor from ICAR – KVK Krishnagiri

facilitated the two days training program.

The FPC team was trained by ICAR - KVK, Krishnagiri on climbing coconut trees in October 2021. The MACOSA – 81 team sponsored the Coconut tree climbing machines to the FPOs.

Yermunai FPC organized an awareness camp for farmers on Aquaculture at Dhottadhimmanahalli village due to World Fisheries Day. Tamilnadu Dr. J. Jayalalithaa Fisheries University Professor came to the program explained about the importance of quality seed and proper stocking for sustainable Aquaculture production. Organized a workshop through the Department of Sericulture about Sericulture and its Schemes.

4.3 BUSINESS ACTIVITIES

Yermunai FPC started its first flower business activity in August 2021. The team exported Chrysanthemum and Rose flowers to the Madurai flowers Market.

Yermunai FPC started its first Vegetable business activity during the Corona pandemic in May 2021. Even the local vegetable market closed for some days. Hence the FPC team started to procure the fresh vegetables from the farmgate and sold nearby villages through a mobile van. Because of the activity the farmers and the consumers benefitted each other.



Pasumai Boomi FPO successfully established an Input shop and inaugurated in September 2021 at Pillari Agraharam village. The Input shop was inaugurated by the DDM, NABARD and Director of ARCOD.

Yermunai FPC started to procure vegetables from the member farmers and local farmers and delivered to Tata Electronics Private Limited (TEPL). This opportunity came as Yermunai FPC participated in an earlier auction conducted by TEPL in January 2022 and won the auction by quoting the best price.



CEOs and Board of Directors from both FPCs attended a Business meet with Krishnagiri, Dharmapuri and Theni District FPOs in December 2021. And the FPO team attended a Buyer and Seller meeting at the Hotel Krishna Palace, Hosur. This meeting was organized by ESAF in January 2022. These meetings would help the FPOs to market their farm produces at the best price and the farmers will get benefited.

During the year the Business turnover of Pasumai Boomi FPO is Rs. 26 Lakhs and Yermunai FPO has done Rs. 11 Lakhs of Business.

The Farmers and Board of Directors from Yermunai FPC participated in a Cultural event held at Ullukkurukkai on 27th February 2022. This event was organized by Tata Electronics Private Limited Company to thank the Yermunai FPC's farmers for supplying vegetables to Tata Company and also the farmers near to the Tata Company.



5. PROMOTION OF GIRLS EDUCATION - LAMP

The project was initiated in the year 2018-19 with the support of Luminous Power Technologies Pvt. Ltd. The objective of LAMP is to promote girls education and make them champions in life. 100 girl students studying in 9th standard were selected from 3 selected schools of Shoolagiri block in the year 2018 - 19. During the year 2019 – 20, 50 more students from 9th standard were enrolled. 25 students from 9th standard of GHSS, Haleseebam enrolled in the academic year 2021 – 22.

5.1 ONLINE CLASSES

During lockdown due to Covid – 19 pandemic situations, we were unable to organize the regular special classes in schools as the schools were closed. So we decided to conduct the classes online for the scholars. 539 classes were conducted during the period from April 2021 to March 2022.

Following challenges were faced in conducting online classes.

- Parents did not recharge their mobile phones regularly as they lost their livelihood during the pandemic and lockdown.
- Though the Smartphones were meant exclusively for online classes for scholars, parents and other family members were using scholar's phone.
- Some of the scholars were going to work to fulfill the economic needs of the family
- Only 50% of the scholars attend online classes.
- It is learnt from the parents of scholars that the scholars use the mobile phone other than attending classes such as playing games, watching cinemas, songs and YouTube etc. These practices of scholars forced the parent to stop the scholars from using phone.

5.2 TRANSITIONS OF SCHOLARS

The Government of Tamil Nadu declared that all students promoted to the next class without board exams. So the scholars who studied in 10th & 11th Standard transferred to 11th & 12th standard respectively.

5.3 HOME VISITS

In July 2021, the project coordinators visited the home of the scholars and had discussion with the family



members. The major purpose of the visits was to know the reasons for absenteeism in online classes and the status of the scholars. During the visit, the coordinators emphasized the importance of attending classes to scholars and parents. As a result, the attendance is increased up to 10 to 15%.

During the visits, it was learnt that 2 scholars from 11th standard and

3 scholars from 12th standard got married and 2 scholars migrated, 3 others were dropped out of school. In September 2021, the project coordinators visited the home to select the new scholars.

5.4 SELECTION OF NEW SCHOLARS (3RD BATCH)

It was proposed to enroll 25 more students to the project this year. It was decided to select the scholars from Government Higher Secondary Schools, Haleseebam. 53 students studying 9th standard were identified and informed about the process of selection to become scholars. 40 students wrote the entrance examination which included all 5 subjects for a maximum of 100 marks. Following the entrance examination, the project coordinators visited the home of the students and had discussion with the family members to assess family background.



Interview was held with the scholars at Government Higher Secondary School, Haleseebam for the new batch. Totally 40 students attended this interview. From this, 25 scholars were selected.

5.5 DISTRIBUTION OF SCHOOL UNIFORMS, WRIST WATCHES, STUDY MATERIALS AND CERTIFICATE FILES

School Uniform distributed for 11th standard scholars of GHSS, Uddanapalli and GHSS, Haleseebam and guide distributed for 12th standard scholars of GHSS, Berigai.

Wrist watches were distributed to 175 scholars of 4 schools on 3rd December 2021. Certificate files distributed for the 11th & 12th standard scholars.



5.6 WORKSHOP ON PERSONALITY DEVELOPMENT

A two days' workshop on Personality Development to LAMP scholars was held in 4 batches in the months of October and November 2021 in their school campus.

We focused the topic on the first day of the workshop on self-awareness, communication skills and its types and personal hygiene with various activities. The second day of the workshop, we focused stress management, coping with emotions and the importance of girl empowerment

with different activities and role play. The facilitators used the Power Point presentation for stress management and coping with emotions.

5.7 WORKSHOP ON CAREER COUNSELING

It was planned to conduct a workshop on Career counseling – Phase I for the LAMP scholars of GHSS, Uddanapalli, Berigai and Immidinayakanapalli studying in 12th standard. It was held on 11th & 12th



December 2021 at ARCOD Namma Veedu, Rayakottai and facilitated by the team of Agnoshin technologies Ltd. Chennai. The sessions started with various topics like soft skills, the process of

selecting a course, the importance of improving skills, explanation of various courses in arts and science stream.

Career Counseling – Phase II was conducted on 12th & 21st March 2022 with the support of ARCOD – India Literacy Project. The sessions started with Visual Holland Code Test and the scholars understood



the various courses. The facilitators mentioned about the courses nearby the scholars locations and explained how the selection process will be in colleges and Institutions of Technology.

5.8 WORKSHOP ON LIFE SKILLS

The workshop on life skills was held on 25th December 2021 at ARCOD Namma Veedu for the scholars of 9th & 11th Standard of GHSS, Uddanapalli and Haleseebam. We focused on coping with emotions,



creative and critical thinking. It was facilitated by Mr. K. Loganathan, Project Manager of ARCOD – India Literacy Project with various activities. As a part of this workshop our scholars celebrated Christmas.

Workshop on Life skills held for the LAMP scholars of 9th & 11th Standard of GHSS, Uddanapalli and Haleseebam on 3rd & 4th March 2022. We focused goal setting, problem solving and decision making for 9th standard scholars and girl empowerment for 11th standard scholars.

5.9 INTER SCHOOL COMPETITIONS

Inter School Competitions was held on 20th February 2022 at ARCOD Namma Veedu for the scholars of 4 selected schools. The competitions were held in various places in the campus.



The following scholars participated in various competitions like Essay Writing, drawing, poem writing, oratorical, running and Kabaddi. Scholars also performed dance, drama and singing.

5.11 SENSITIZATION MEETING WITH PARENTS



It was planned to conduct the meeting with parents on 30th & 31st March 2022 at Hotel Gowri Shankar, Hosur. The parents of selected scholars were participated in this meeting. The Project Coordinators discussed with them about choosing their career, the importance of spending time with their children, the importance of education especially for girl children and how they face their problems in society with realistic examples.

6. CHILDREN OF KRISHNAGIRI

The Children of Krishnagiri is an initiative to support the children infected by HIV in Krishnagiri and Dharmapuri Districts. The following activities were carried out during the year 2021 - 22.

6.1 DISTRIBUTION OF NUTRITION KITS

Nutrition plays a vital role in the health of the children. The children have been supported with the Nutrition Kits for the past 8 years. The Nutrition kit with the following materials worth of about Rs. 750/- distributed to the children every month.


Thanks to sponsors for their support for Nutrition for 220 children. We could see that the CD4 count of these children significantly improved as a result of Nutrition Kits over these years.

6.2 CENTER FOR EXCELLENCE

With the support of Saint Gobain India, the center for excellence is set up at Namma Veedu. The objective of the center is to support the children to improve their learning and academic performance. Initially 25 girl students studying 10th to 12th standards were selected for intervention. These children were provided Android Mobile Phones to facilitate online classes by the part time teachers. The children were oriented on using android mobile phone and online platforms like Zoom and Google Meet for learning. Learning materials were also provided to them. The project team visited the students at the block level and organized remedial coaching classes. Apart from this, efforts were made to provide one to one coaching to the children based on the need. To monitor the progress and improvement in learning performance assessments were conducted. Based on the results focus was given to those lack behind.

Various residential workshops were organized to the children in different phases. Child Rights, Personality development, life skills, building confidence and motivation, medication and meditation, computer literacy, career guidance and counselling were the topics covered during these workshops. The COVID and Omicron impacted challenges in reaching out to the children.

A booklet with information on the importance on Balanced Nutrition was developed, printed and circulated among all the Children of Krishnagiri.



6.3 GIFT FOR CELEBRATION OF PONGAL

The festival of Deepavali has been celebrated for the past 10 years till 2019. The celebrations were cancelled for the past 2 years due to COVID 19 pandemic. This year it was decided to distribute Cash Gift of Rs. 1,000/- to each child for celebrating Pongal. The amount was transferred to the bank account of 120 children, the remaining 100 children visited the office and collected cash.

6.4 MEDICAL INTERVENTION

Thought the general health of the children is improved over years, some children got opportunistic infections. Those children were immediately followed up and taken care to be provided with medical treatment and counselling.



6.5 INDIVIDUAL SPONSORS

ARCOD continues to get support from individual sponsors. ARCOD expresses its gratitude to all the individual sponsors who are constantly extending their support for the children of Krishnagiri.



7. ANNIVERSARY & PONGAL CELEBRATION

The 34th Anniversary of ARCOD and Pongal Celebration were held at the office premises at Rayakottai on 11th January 2022. Board members, staff team and guests gathered for the celebration. They reflected on the past and floated ideas for the future of ARCOD. Earlier, the gathering celebrated Pongal in the morning.

3 Governing Body Meetings and 1 General body meeting were conducted during the reporting period.


